Three Arrested in Indian Trail Home Invasion

At approximately 130 PM Wednesday afternoon, Union County Sheriff's Deputies responded to a 911 call of a home invasion and armed robbery at 1139 Briarmore Drive, in the Brandon Oaks Subdivision. Deputy Sheriff Chris Allen, currently assigned as a Contract Deputy to Indian Trail, located and detained one of the suspects minutes after the robbery call. A perimeter was established and Sheriff's Canines were called in to search the area. Crime Scene Investigators responded and processed the scene.

Deputies located an abandoned vehicle nearby, and were able to identify this as belonging to the suspect(s). The vehicle was seized as evidence, and a search warrant obtained. Detectives located the stolen property taken in the home invasion, as well as the 22 caliber revolver used in the robbery, in the trunk of the Saturn automobile.

Detectives were able to identify the two additional suspects, and warrants were obtained for Kidnapping and Armed Robbery. All three were arrested without incident, and remain in the Union County Jail at this time.

In addition to being charged in this incident, Detectives were able to link Keith Spencer Gaines (19) to two separate robbery cases from 2011, also in Indian Trail. On July 10, 2011 Gaines is alleged to have robbed a Dominos Pizza delivery driver of \$20 cash and a pizza. On October 25, 2011, Detectives allege Gaines committed a similar robbery against a New York Pizza and Pasta delivery driver, stealing a cell phone and \$25 cash in that robbery.
